

HORSE OF THE YEAR SHOW PUBLIC CAMPING

Horse of the Year Show Public Camping is available to all spectators. 3 Day and Day Camping passes are available, which includes access to the Horse of the Year show and 1 non powered camp site.

Public campers are able to access the camping facilities and amenities on site, but be quick spaces are limited.

Public Camping is available in three zones only - red, blue and green. Camp sites are not allocated at time of booking, but upon arrival at the Horse of the Year show.

Before you decide to purchase a Public Camping site please read this important information:

CAMPING

- Your camping pass entitles you to access to the Hawke's Bay A & P Showgrounds and Horse of the Year Show while your ticket is valid and 1 Non powered campsite in your selected zone.
- If the zone you have selected is at capacity, upon your arrival at the Showgrounds, you will be allocated another area by Horse of the Year management.
- Camping passes must be displayed either on the vehicle dashboard or attached to the tent.
- Public camping is only available in the Red, Blue and Green zones. No Public camping is available in the Purple Zone due to Health & safety reasons.
- All Public campsites are Non powered.
- Camping Sites are allocated on a first come first served basis.
- Public Camping tickets are limited to 100 tickets.
- Public campers are only entitled to camp and have access to the Hawke's Bay A & P Showgrounds for the duration of their ticket. If they intend to stay longer they will need to purchase additional tickets.
- Proof of purchase / iticket receipt does not entitle you to entry to the camping area or the Horse of the Year Show. An official Horse of the Year wristband and parking pass is required.
- Wristbands and parking passes will be sent out in early February 2017 to the postal address provided.
- All campers camping in a power site area will have to pay for power whether they connect or not.
- Anything connected to a power supply must have a **current electrical certification**. This will be monitored and if this certification is not held the cord will be disconnected and removed.
- All camping material (including tents, vehicles, etc.) must remain within the site boundaries set in the camping areas. Any additional vehicles or equipment must be removed from the camping area. Parking is available on the golf course or in day parking areas.
- Any vehicle or material found outside of their site boundaries or blocking access will be towed or confiscated at the owner's expense.
- No infrastructure or grounds may be tampered with under any circumstances.
- No vehicle access at Gate 2 between 8am 1pm on Saturday 11th March 2017. All vehicles must access through Gate 1 or Gate C between these times.
- Additional Camping applications submitted online after the closing date (1st February 2017) may not be guaranteed a site on the Showgrounds.

<u>GENERAL</u>

- Any rider or person contravening Hawke's Bay A&P Showground rules and regulations will be liable for a fine not exceeding \$100 and disqualification from the show indefinitely. These rules are available at the Equestrian office at the Show.
- The **consumption of alcohol** is limited to the bars, café, function centre and camping areas. The Grandstand is an alcohol free zone. **No alcohol** is to be consumed or open containers carried within the secured area including behind the grandstand and around the arenas and stabling blocks.
- Dogs are <u>not</u> allowed on the Hawke's Bay A&P Showgrounds.
- Except for trade exhibitors, no access is allowed into the trade area, 30 minutes after the last activity of the day.
- Permission of the organising Event Management Company must be obtained for any product or service to be sold, advertised or performed outside of the designated trade and food areas.
- No personal notices are to be displayed anywhere around the grounds.

HEALTH & SAFETY

- Hawke's Bay A&P Showgrounds are classified as a construction and multi-hazard site from 8am Monday 22nd February 2017 – 9am on Saturday 4th March 2017 and Monday 13th March 2017 until 27th March 2017.
- Between 10am Saturday 4th March 2017 Sunday 12th March 2017, the Hawke's Bay A&P Showgrounds will no longer be a construction site, however will remain a multi-hazard site.
- All competitors and spectators etc. are responsible for their own safety and must act safely at all times.
- All people at the Hawke's Bay A&P Showgrounds must comply with all the Health & Safety conditions of the show.
- Any hazards identified need to be reported to the HOY Equestrian office.
- Once dark or low visibility occurs, no vehicle movement is allowed (this includes motorbikes, cars, Utes, machinery etc.) in the secure area unless permission granted by HOY Management.
- A full copy of the Health and Safety plan is available at the HOY Equestrian office at the Show.
- The use of bikes (including push bikes) is allowed on the grounds and normal road rules apply. The following rules must also be adhered to:
 - Driver has a current driver's license (except push bikes)
 - Helmet to be worn at all times while bike is in operation
 - Lights must be on during operation (if possible)
 - Not to be taken into the secure area, around practice arenas or within stable/yard areas
 - Speed limit of 10km maximum at all times
 - Limited to one passenger (if applicable to bike) who must also be wearing a helmet
 - Operated in daylight hours only
